Waiver, Release and Covenant Not to Sue

In Consideration of Fort Clark Gun Club, a Texas unincorporated not-for-profit Gun Club, permitting me to engage in their firearms-shooting activities of that Gun Club, I, on my own behalf and on the behalf of my heirs, representatives, administrators and assigns, hereby waive and release any and all claims, demands, causes of action suits and rights I, or anyone action on my behalf, might have against that Gun Club, its officers and/or directors for personal injury, including death, loss or damage to my property, which I (or anyone claiming by or through me) may have against that Gun Club and its officers and/or directors.

Further, I agree that **I will not**, nor will anyone acting on my behalf claiming by or through me, **bring or maintain any suit** in Court to assert any claim against that Gun Club, its officers and/or directors that I might have arising out of my participation in any activities sponsored, sanctioned or approved by that Gun Club, its officers and/or directors.

I understand that engaging in Defensive Pistol shooting activities involves a very hazardous and dangerous activity with accompanying risks of personal injury or death and loss or damage to personal property, and I HEREBY VOLUNTARILY ASSUME THOSE RISKS.

I have read and understand the foregoing provisions of this Waiver, Release and Covenant Not to Sue and I have executed this instrument voluntarily on this date.

I recognize that the Gun Club, its officers and/or directors are not obligated to permit me to participate in any of the Gun Clubs activities and may terminate my participation in such activities at any time and for any reason.

This instrument shall not preclude the prosecution of any claim that I might have against persons or entities other than Fort Clark Gun Club and/or its officers and/or directors. In other words, **I am releasing, waiving my rights, and agreeing not to sue Fort Clark Gun Club, its officers, and/or directors at any time for any reason.**

This instrument shall remain in full force and effect indefinitely.

- ✓ **CARRY YOUR FORT CLARK GUN CLUB MEMBERSHIP CARD WITH YOU.**
- ✓ **MEMBERS ARE RESPONSIBLE FOR THEIR GUESTS ALONG WITH THE ASSOCIATED GUEST FEES AND MUST ACCOMPANY THEM ON THE RANGE AT ALL TIMES.**
- ✓ **REPORT ANY TRASH OR DAMAGE YOU DISCOVER ON THE RANGE TO A CLUB OFFICER.**
- ✓ **REPORT ANY NON-CLUB MEMBERS YOU OBSERVE USING THE RANGE (CRIMINAL TRESPASS OFFENSE).**
- ✓ **LOCK THE GATE BEHIND YOU WHEN USING THE RANGE AND WHEN YOU DEPART.**
- ✓ **NO SHOOTING AT NIGHT.**
- ✓ **RANGE KEYS MUST BE RETURNED TO THE SECURITY GATE ON THE SAME DAY THEY ARE SIGNED FOR.**

NO SMOKING PERMITTED ON THE RANGE DUE TO FIRE HAZARD

NO TRACER OR INCINDIARY ROUNDS DUE TO FIRE HAZARD

NO TANNERITE DUE TO FIRE HAZARD

KEEP ALL UNCASSED WEAPONS POINTED DOWN RANGE

SHOOT ONLY ON ESTABLISHED RANGES

NO GLASS TARGETS

DO NOT PLACE TARGETS ON TOP OF THE BACKBOARDS

POLICE UP YOUR BRASS

REMOVE ALL TRASH AND TARGETS OFF OF BACKBOARDS AND OFF OF RANGE

EYE AND HEARING PROTECTION REQUIRED

STOP ANY UNSAFE ACT YOU MAY OBSERVE

BE A RESPONSIBLE SAFE SHOOTER, SET THE EXAMPLE
